"Sudan's Building Improvements Needed"

Nobles, it has recently come to the attention of the Board of Directors that Sudan's building may have several problems that must be addressed. The most pressing of the problems seems to be the roof and it may need to be completely replaced. There are apparently other problems and the Board of Directors is in the process of identifying those problems and making a determination of what to do.

Some rumors are circulating that indicate the board wants the building condemned. Another rumor is that the board wants to sell the building/property and move the office to another city. These rumors hold no truth. The prevailing idea is to identify what problems we have with the building and determine a course of action.

Our headquarters building is somewhat of a historical landmark, not only to New Bern but to Sudan Shriners as well. Tradition is important with Shriners and so is our building. It's the home of Sudan and it is the place we identify as our home (although it is not Sudan's first home building) but it has been home since 1951.

Our building may offer opportunities for financial stability into the future if we can fix what is wrong and market the building for rental purposes.

I have appointed a Building Committee with High Priest & Prophet Ken

Bennett as Chairman and members Chief Rabban Bruce Bulluck and Assistant Rabban Steve Norris as original members, with the Potentate's instruction to include as many others on the committee as is necessary to get the job done. Treasurer Olen Smith, Recorder B. F. Smith, Jr., and Building & Grounds Co-Chairmen Earl Temple and Marvin Raines have been added to the committee membership thus far.

Stephen presented the money to the Johnston County Shrine Club at their May 8th meeting. We will always be grateful to the Shriners and for all they do for the children.

Noble Syd Hill's Journey



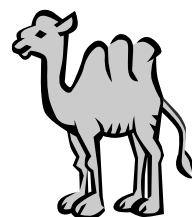

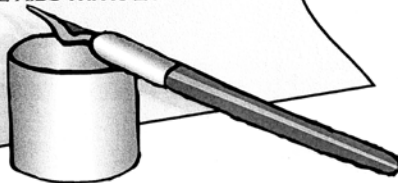

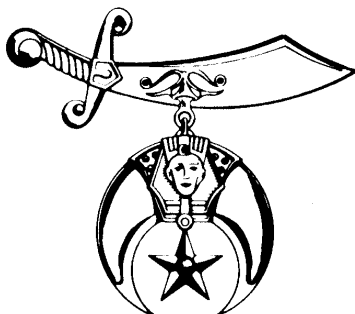
