1. The deadline for **all** entry fees will be Oct 21, 2011 at 7 pm
2. The entry fee for the Adult Trout Tournament shall be \$50 per person Jr Angler shall be \$25. Any fee submitted **after** Oct 17, 2010 at 6 pm and prior to start of tournament shall be charged an additional \$25. Entry fees are non-refundable.
3. In the unlikely event of adverse weather conditions, the tournament shall be called off 24 hours prior to the official start time. The alternate date shall be Oct 29, 2011.
4. Prizes will be paid for largest trout. In case of a tie, the first fish weighed in will be declared the winner. (NOTE: please release all other fish live to support stock status)
5. Entrants must possess all required fishing license for areas fished.
6. Fishing can be done from shore, pier or boat in waters of Pamlico, Beaufort, Craven and Carteret Counties.
7. Official fishing time starts at 6:00 am and last weigh-in is at 4:00 pm. Must be on Pamlico County Shrine Club property by 4:00 pm or weigh-in will not count toward prize money.
8. All fish must be caught by hook and line only. Any commercial gear use or markings will be basis for disqualification. This shall be up to the discretion of a Tournament Officials.
9. All fish must be fresh, fit for human consumption, and pass inspection of Tournament Committee.
10. All winners may be subject to a polygraph test.
11. All protest must be made in writing, accompanied by a \$150 cash fee, no later than 5:00 pm on day of tournament. If protest is upheld, the \$150 fee will be returned.
12. All decisions by the Rules Committee shall be final.
13. Violation of any tournament rules will result in disqualification. The Rules Committee shall be sole judge and decisions are final.
14. A NC Marine Fisheries marine biologist and/or Officer may be on hand to advise the Tournament Committee.
15. Each entrant will be eligible for only one of the primary cash prizes in each category.
16. **All trout must meet current NC Marine Fisheries size limits at weigh-in.**
17. All tournament participants consent and authorize the tournament sponsor and the advertising and public relations agencies to use and reproduce names, voices and/or photographs, whether taken or recorded, and to circulate the same for any and all purposes of publicity and advertising of all kinds and descriptions in any and all media formats.
