Shelton's Harley-Davidson Toy Run



November is Toy Run time and on November 6th Shelton's Harley-Davidson, Inc. had their 16th fall open house and H.O.G. Toy Run. Each year Shelton Davis and his wife Sharon sponsor a Toy Run from Smithfield to Goldsboro. This year the Toy Run drew between 400-500 bikers. The entry fee is either a new toy or \$5.00 and for this they get to ride in the parade and receive a meal ticket.

The Toy Run assembled at the Mall Shop in Smithfield and left Shelton's about 11:00 am with Mrs. Santa and Santa on the lead motorcycle. Behind them were the rest of the toys in a trailer and at least 400 motorcycles. The Toy Run followed US 70 from Smithfield to Goldsboro. The Johnston County Sheriff's department provided escort for the Toy Run from Smithfield through Johnston County and at the Wayne County line the Wayne County Sheriff's department took over and escorted the Toy Run to Goldsboro. In Goldsboro the Toy Run paraded up Ash Street, turned left on Herman Park and ended at Shelton's Harley-Davidson Store on the US 70 bypass. At the store the procession was greeted by Wayne Shrine Club members. Sudan Mini-Riggers and more bikers.

Shelton uses the Toy Run to sponsor several charities. All the toys are donated to the Shriner's Children's hospitals and Sudan Mini-Riggers pack them in 2ft X 2ft boxes and load them onto a delivery truck. The toys are divided evenly and this year 11 boxes of toys were sent to the hospital in Greenville, South Carolina hospital and 11 to the burn center in Cincinnati, Ohio. After the toys are packed the Sudan Mini-Riggers performed a parade routine for the crowd.

Shelton Davis started 16 years ago with the Harley Owners Group riders to collect toys for needy children and still works with the Sudan Shriners of which he is a member. He said the reason Bikers do it is that "Bikers have big hearts". Then Shelton helped serve up a BBQ lunch for all which was followed by a 50/50 drawing, door prizes and discounted merchandise. The funds collected were donated to other charities and included Shop With A Cop, the American Cancer Society (Relay for Life) and MDA.

Shelton Davis was raised to the sublime degree of Master Mason in Palmyra Lodge #147 in 1984. He then petitioned Scottish Rite and received his 32 degree at the Valley of Raleigh in 1984. Later that year he was created a Shriner at the Shrine Temple in New Bern and then joined the Dunn Shrine Club. Shelton received his 25 year pin from all three organizations.

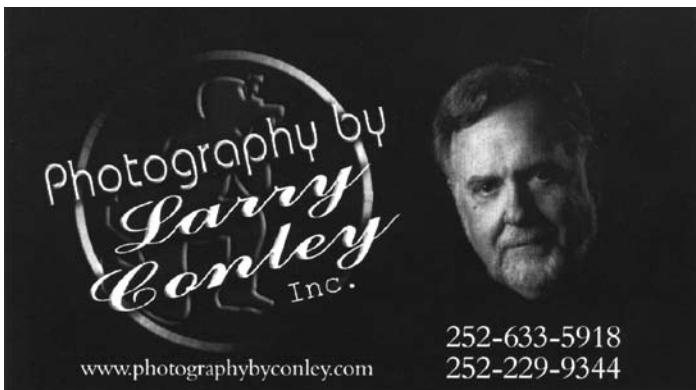

Help for Any Child

DUDLEY -- Megan Sutton squeals with delight as she shows how she can walk with a little help from her dad. It is a big achievement. Two years ago, the 3-year-old couldn't move anything but her neck.

Bailey Sutton, 9, who is not related to Megan, can perform demanding clogging routines. A year ago, her right foot was rolled over on its side, making simply walking difficult.

The progress both girls have made can be traced, in part, right back to Wayne County -- and a plate of fried fish.

Proceeds from the Wayne Shrine Club's fall fish sale help support the Shriners' Hospitals, where Megan and Bailey were treated. Currently, 30 Wayne County children are receiving help from the program.

Megan, the daughter of Chad and Leigh Ann Sutton of Seven Springs, was 7 months old and at her day care on May 28, 2008, when her family first learned something was wrong with the little girl.

The Suttons drove Megan to Wayne Memorial Hospital and then to Pitt Memorial Hospital at Greenville where she was seen by a neurologist.

"By 11 o'clock (that night) we knew what was wrong with her. She had transverse myelitis," Sutton said. "It is neurological in which the autoimmune system attacks the spinal cord and interrupts nerve flow and causes lesions on the spinal cord. The spinal cord swells and damages the sheath around it. It usually starts in the lower extremities and works its way up, usually very rapidly."

Megan was hospitalized at Pitt through August.

Shriner George Raecher, who along with Tom Ferrell, is co-chairman of the Wayne Shrine Club's children activities groups that handles hospital patients, found out about Megan's condition and suggested the Shriners' Hospital in Greenville, S.C.

"When this first happened the only thing she could move was her neck and the rest of it was totally paralyzed," Sutton said. "Little by little, little things started waking up, moving a little bit and now you see... we have started on walking a little bit now," he said. "I love (Shriners' Hospital)," Mrs. Sutton said. "It is amazing what they do. You don't have to ask for help, they just offer."

Bailey, the daughter of Kris and Kristy Sutton of Seven Springs, suffered from tarsal coalition in which the bones in her feet were fused together over the joints.

A dancer since age 3, Bailey could only sit and watch her fellow dancers. At school, classmates helped her on the stairs and with her lunch. Now she has no trouble running. "I am back in dance," she said. "I did a dance solo."

Her journey back to the stage was not an easy one, Bailey said. The Suttons went to the Shriners' Hospital in Greenville in January and Bailey had her surgery in February. She was hospitalized for four days. "No charge at all. It is awesome," Mrs. Sutton said. "When you go you keep your receipts for like your gas and they paid for our motel room."

Mrs. Sutton recalls Bailey saying, "look, Mama, look that is the first time I have seen my foot straight." Mrs. Sutton said her family has already referred one little girl to the program.

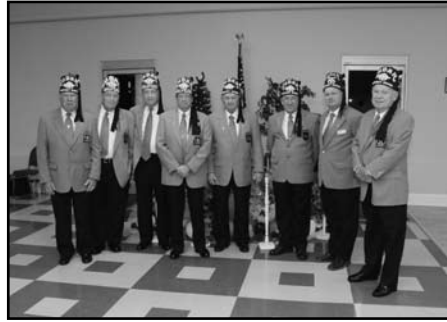

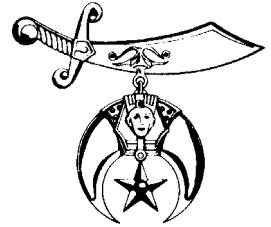

Shriners Hospital Works a Miracle

Mackenzie Paige, the 4 month old daughter of Anthony and Melissa and sister to Landon of Kinston, received groundbreaking surgery at the Shriners Crippled Children's Hospital in Greenville, S.C., on September 28. Her orthopedic surgeon, Dr. T. Whitney Gibson, said she was the youngest person to ever receive this type of surgery in the world.

Mackenzie was born with Developmental Hip Displasia, DDH. This was discovered when she was only a couple of weeks old. The Shriners Hospital was called to see if she could be seen there. Since that time she has now made four trips to the Shriners Children's Hospital at Greenville, S.C.

Dr. Gibson was interviewed on Fox 8, Greenville, S.C. and told us the day before that they were not sure they were going to be able to do this surgery since it usually is not done until the child is at least 12 to 14 months old.

The surgery went well; then Mackenzie was placed in a hard shell body cast from her waist down to her ankles. She will wear this for six weeks and then go back to the hospital to have that cast removed and another put on her for another six weeks. This is to allow for her body growth. They anticipate the outlook to be very good, and the bone and joint in her hip should form correctly now. The TV Station said it would follow up on this story throughout the entire treatment of this little girl. You can see her and her story on foxcarolina.com, the website for Fox 8.

Thank you, God for being there all the time. Thank you, Shriners, for allowing God to use you in such a dynamic way. The Shriners Hospital is truly a wonderful place. The doctors, nurses and all their personnel were, and are, like family. I can't say enough good things about the Shriners Children's Hospital. I can't even begin to imagine what all the great services she has received and will be getting would have cost. They don't ask for anything, just provide services to everyone at no cost. That has to be a God thing.

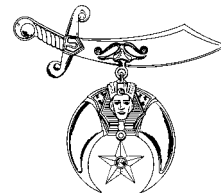
