

Potentate's Message

Nobles and Ladies:

Looking back at the Winter Ceremonial and the efforts of so many to make it a success certainly instills pride in an in-coming Potentate. I am most grateful for the commitment from so many to make our Winter Ceremonial one of the best ever. Although there were some bumps initially at our headquarters hotel, the balance of the weekend was well executed with many changes made to make the entire Sudan experience more enjoyable for all.

It is not without sacrifice and dedication from those supporting the Potentate, that the ceremonial was memorable for all. The support shown by the entire Rocky Mount Shrine Club, the Sudan Prowlers, and all of their ladies, as well as The Wrecking Crew, Divan, and the Sudan Shriners officers and staff, resulted in a weekend to remember. The addition of a cold and blustery day accompanied by snow certainly added to the memories. Any Shriner should be proud to know that with such commitment to the tasks, anything can be accomplished.

With that being said, we should celebrate our successes but also take ownership when we fail to meet expectations. I am happy to report that much has been done toward completing the building restoration project; however, there is much left to do. Current projects underway should be completed soon, unfortunately, upon their completion, repair projects will grind to a halt due to a lack of funds. Examining our current cash situation reveals that we simply don't have the money to continue our building improvement plans. While this was not unexpected, it still remains a bit of a disappointment.

The 2011 operating budget for Sudan Shriners allowed \$72,000 from the General Fund to be earmarked for our restoration project. That money is not yet available due to the lack of incoming revenue from dues payments. A full 67% of Sudan's operating revenue comes strictly and solely from dues. Without it, we cannot continue to fund our restoration project.

For the majority of you, who have timely paid your Sudan dues, thank you for your attention and continued dedication. For the 1400 members who have yet to pay their 2011 dues, be reminded that the shortfall in dues income amounts to \$105,000. We really need your help in getting these dues remitted as soon as possible so that we can continue our restoration project and fund the balance of the operating expenses for 2011.

Dues can be paid by check, credit card, and soon, securely on-line through "PayPal" with or without an existing "PayPal" account. Be assured that Sudan Shriners is making every effort to make the dues payment process as easy and convenient as possible. For club secretaries and unit directors, now is the time to review the NPD list available from the Sudan Shriners office and contact those Nobles in your club or unit. Encourage them to pay their dues. Many have paid local club and/or unit dues and have simply overlooked their Temple dues.

Another opportunity for funding the building restoration project is through local fundraising events and club/unit donations. We all know that our mission is supporting the Shriners Hospitals for Children, the patients there, and providing transport to and from when needed. We do not want to divert any money from our cause carelessly or irresponsibly; however, if your group typically has a fundraiser for donations to the Transportation Fund, an alternate building fund restoration fundraiser would be much appreciated. Hospital Patient Service Coordinator, Donna Horton, has assured me that the Transportation Fund has sufficient funds for the balance of the year allowing clubs and units an opportunity to make donations to the restoration effort.

Be reminded that we never combine charitable and fraternal money. A fundraiser promoted as benefiting the hospitals is a charitable function and as such, all funds must be designated for the hospitals. Building fund money must be clearly promoted as a fraternal fundraiser with the appropriate fundraising request form submitted and approved. A specific fundraiser for the restoration project might be an opportunity for your group to participate in continuing the heritage of Sudan Shriners, by contributing to the preservation of our historic



and iconic building. Many groups have already contributed in this way and every dollar means another glass pane re-glazed or another floor tile replaced.

Please take the time to bring this to the attention of all of your members as soon as possible and as always, I thank you for what you do.

Temple Repair & Restoration Project

As you may know, Sudan is engaged in repairing and remodeling the temple. Our building is well past needing much work to bring it up to the standards we expect.

So far the third floor roof has been replaced, the lower rear roof has been repaired and the Nelson Banks Room roof has been resealed and additional drainage installed.

Contract has been let to restore the large 10 ft. by 20 ft. ornate window on the Broad St. side of the building.

Sudan Truckers have painted the entire wrought iron fence and all outdoor black fixtures.

The Mini Cars have restored their meeting room and glazed and painted their windows and the Fire Brigade has pressure washed the entrance concrete pads.

Havelock Shrine Club has cut the front shrubbery, removed all debris and plans to refurbish the upstairs storage room.

The Roadrunners painted the entire office and hallway and also oversaw carpet installation and the Cooligans have begun restoration of exterior first floor windows.

The Pamlico Shrine Club is about to refurbish the Nelson Banks Room.

Nobles Ed Dixon and J. R. Holloman have replaced ceiling tiles and reattached stairway railing and Noble Charlie Justice repaired an area of the wood flooring in the ballroom.

Noble Gary Tucker, a painting contractor, sent one of his crews to paint the entire front lobby.

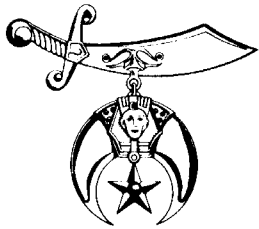

Fairmont Shrine Club's Nonagenarians

The Fairmont Shrine club has a heritage of long-standing service. This heritage continues today through the service of two nonagenarians. If you are like me you would have to look up the definition of nonagenarian. Let me save you the time and trouble. A nonagenarian is a person in their nineties.

I believe that a quote from Jack Johnson's wife Rose sums up the concept of Shrine service when she proclaimed "Jack feels that every Shriner should experience a trip to the Shriners Hospital in Greenville, SC, as he has, to fully appreciate the words "No man stands so tall as when he stoops to help a child".

Let me tell you a bit about our nonagenarians of whom we are so proud and who have strengthened our foundation of Shrinedom in Fairmont, NC through their years of selfless and tireless service. We are so grateful and thankful for the service of John L. (Jack) Johnson and Dr. P. C. Purvis both of whom were born in 1920.

The elder of the two is Dr. P. C. Purvis who was born January 9, 1920 and was raised in Proctorville, NC. P. C. began his Masonic journey when he was raised in Fairmont Masonic Lodge #528 on 02/25/1947. He became a member of the Scottish Rite, Valley of Wilmington, Orient of North Carolina in 1964. He joined the Fairmont Shrine Club in 1965. He attended the University of North Carolina at Chapel Hill followed by Emory University Dental School. He served his country honorably as a Commander in the Dental Corps of the United States Navy. He served his community as a Dentist from 1943 to 1991. His partner since 1944 is Peggy Haynie from Decatur, GA. She tells a funny story about how P. C. told someone how they met after they moved to Fairmont. She says they met after P. C. saw her "walking" down Peachtree Street in Atlanta, GA with a person he knew. He asked that person for an introduction. Ultimately they were married and moved to Fairmont. When asked how they met P. C. said that she was an Atlanta "street walker". They have walked the streets of service and love for 66 years. P. C. and Peggy have 3 children, Judy, Tommy and Blair.

John L. Johnson is the youngest of our nonagenarians by 10 months. He is known as Jack. He was born November 15, 1920 and was raised in Wilmington, NC. Jack began his Masonic journey when he was raised in Fairmont Masonic Lodge #528 on 03/17/1975. He became a member of the York Rite under the Commandery of Palestine 20. He then became a member of the Fairmont Shrine Club in 1975. He is currently the Secretary of the Fairmont Shrine Club and has served as Vice-President and President. He was a member of the Robeson County Bagpipe Band with Neil Walters and Byron Tedder where he played the Tenor Drums. He is a founding member of the Sudan Pirates and he built the Sudan Pirates Pirate Ship with the late Byron Tedder. Jack graduated from East Carolina University and is a devoted, dedicated and staunch Pirate since his graduation in 1946 and receiving his Masters of Education in 1949. While finishing school he married Rose Graham on June 7, 1948. It is an interesting fact that Rose graduated the morning of June 7, 1948 and they were then married that same afternoon. They have traveled the streets of service and love for 62 years. Jack and Rose have two girls, Rosemary and Joy.

Thank you Nobles P. C. and Jack for your many years of service, commitment and example. You have made the Fairmont Shrine Club, Sudan Temple and the Shriners Hospitals for Children stronger by your many selfless acts. May we strive to ever follow your example.

No candidate for initiation has been any more surprised at the events of a ceremonial weekend than Noble Joseph "Big Daddy" Moore was at the Winter Ceremonial. With much humility, "Big Daddy" was honorably recognized by his fellow nobles.

One definition of 'legacy' reads, "anything handed down from the past, as from an ancestor or predecessor". His legacy is an inarguable testimony to the resilience and commitment that 'One' Noble has displayed in a near half century of being a Sudan Shriner.

Many candidates have been teased, prodded and cajoled by Noble Moore over his many years. Not one has left the ceremonial without the respect being given to the Shriner who along with the expertise and purposeful planning of the Wrecking Crew, insured that each truly 'got his monies worth'.

In a New Bern "Sun Journal" article, Noble Moore's story was told shortly after the Winter Ceremonial in January and it is reprinted here with permission.

Big Daddy Honored by Shriners

NEW BERN — Being the model for a Sudan Shriner in action and in unwavering reliability wasn't necessarily the goal of Joseph "Big Daddy" Moore.

But few if any Shriners will tell you there's not a better man to learn from, to emulate and to strive to be like.

Saturday morning in the Sudan Temple prior to the annual business meeting, Moore was honored with a lifetime membership and presented the distinguished title of Captain Emeritus of the Provost Guard. His wife of 57 years, Melrose, and sons Ron, Lee and Glenn were there to see it.

"I couldn't think," the humbled Big Daddy said of the surprise ceremony.

Though he said little, the smile and tears of joyous emotion said plenty.

"I knew I had done something wrong," he said of being asked to come upstairs to the temple's auditorium. "They told me, 'The potentate wants to see you.'"

Hardly anything wrong. Instead, he was led to a seat by his wife and sons and bestowed a well-earned recognition from out-going Potentate Mike Farrell.

Moore, who celebrated his 90th birthday two days before Christmas, has been a member of the Sudan since the Winter Ceremonial in January 1964. He hasn't missed a ceremonial since, going to every one for 47 years. This weekend is his 141st in a row.

And as a member of the Provost Guard, he's been in charge of the candidates' initiation for about four decades. Safe to say, every current living Sudan Shriner has been in contact with Big Daddy.

"He is absolutely what every Shriner should want to be," said John Moore, no relation and a Shriner from Pitt County. "He is the model, the mold, that every man should want to be. He is all that and more in being a Shriner. He is the ultimate Shriner."

Stacey Pugh went through initiation in 1995 in Morehead City. He remembers his first meeting with Big Daddy.

"He's the face that every candidate sees when they are initiated," Pugh said. "I was scared of him in 1995."

He chuckled as he said it, and added, "But today, I love him. He's a great Shriner."

When Moore and his wife moved to Greenville in 1961, he operated a Texaco service station — later to become Pure, then Union 76 — on East 10th Street. He also worked a fire extinguisher business, as well as U-Hauls. East Carolina University students came to affectionately call him Big Daddy, and the name never left. By the late 1960s, he was serving burgers aplenty while operating Big Daddy's Chuckwagon next door.

He became a magistrate in the mid-1980s, retiring from it in 1996.

"He's a remarkable Shriner," Pugh said. "He loves what he does, he's the first one there, and he's always there."

Big Daddy shies from the spotlight, and friends and family suspected he would have missed his first ceremonial had he known what was planned. He enjoys the fellowship of other Shriners, is saddened so many of his contemporaries have passed, and says he imparts only the wisdom a candidate already should know.

"Most of them know what a Shriner stands for, to help the burned and crippled children," he said, a smile coming to his face affirming assurance as he added, "I've enjoyed every minute of it."

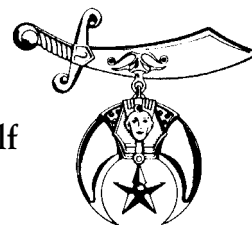

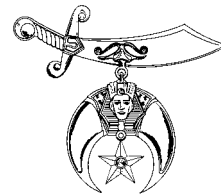
