### **Shriners Children's**

In 1920 at the Imperial Session held in Portland Oregon, Imperial Potentate W. Freeland Kendrick put forth a resolution that created what is now known as Shriners Children's. The resolution passed unanimously, and on September 15, 1922 the first Shriners Hospital for Crippled Children opened in Shreveport, Louisiana to care for children with orthopedic issues. Never to be satisfied with mediocre, the Shriners built nine more hospitals by 1926. The Shrine ultimately completed 22 hospitals in three countries (USA, Mexico, and Canada) and expanded services to include burn care, spinal cord injury, and cleft lip and palate care.

Today Shriners throughout the world raise funds to support the healthcare facilities in providing care, invest in research advancements, assist the families of patients with transportation to the facilities among other needs, and also volunteer in many various ways. Children from birth to age 18 receive care at one of our many facilities. Our name has changed to Shriners Children's, but our values and goals remain the same; we pride ourselves in caring for all children regardless of their families' ability to pay.

This is made possible by the endowment that Shriners have been able to build over the past 100 years and continue to support today through various fundraising activities.

Shriners Children's inpatient and outpatient services are focused on four specialized areas of pediatric care:

- Orthopedic Care - this was the first area of care established. In fact, Shriners Hospitals for Crippled Children was founded out of the polio outbreak in the late 19<sup>th</sup> and early 20<sup>th</sup> century. Today Shriners Children's provides medical and rehabilitative services for children with all types of orthopedic conditions to include congenital conditions, orthopedic injuries, and diseases of the neuromusculoskeletal system.
- Burn Care - treatment for acute and non-acute burn injuries and related scarring, including physical and emotional rehabilitation.
- Spinal Cord Injury - spinal cord injury rehabilitation specifically for children, offering some of the most advanced treatment in the country with a full range of services.
- Cleft Lip and Palate Care - coordinated and comprehensive multidisciplinary care for children with this condition.

Shriners Children's is dedicated to innovative research and it has been a part of our mission since inception. Shriners Children's is committed to the pursuit of seminal, cutting-edge discoveries that result in new knowledge and the ongoing improvement of therapeutic treatments, quality of care and the very best outcomes for our patients and their families. We stay at the forefront of pediatric research to provide high-quality, innovative medical care to children. Our research aligns with our healthcare system's clinical strengths by continually creating tools and building partnerships. Through

these actions and scientific breakthroughs, we raise Shriners Children's clinical research profile around the world. To learn more, go to [www.shrinerschildrens.org/en/research](http://www.shrinerschildrens.org/en/research). We have affiliations with 35 top Research and Teaching Institutions in the United States. In the 2022 operational budget, Shriners budgeted \$38 million to research. Many of the standards of care used today in pediatric institutions across the globe are a direct result of innovations in pediatric care coming out of research completed by Shriners Children's.

Healthcare has been transitioning away from inpatient stays to more outpatient services over the last 10-20 years. In order to be competitive and to remain viable, Shriners Children's instituted some of their own changes. In 2018, Shriners Children's adopted a direction of "more kids in more places." This shift in direction also began a transition that includes changing the model in which care is provided. With decreasing inpatient stays, it became evident that some of the Shriners Hospitals needed to transition to a less acute delivery of care. As a result, a number of the original 22 hospitals have completed transitions. As of this writing, they include:

- **Erie** - transitioned to an outpatient clinic with accompanying rehabilitation services
- **Lexington** - transitioned to an Ambulatory Surgery Center with accompanying outpatient clinic and rehabilitation services
- **Pasadena** - transitioned to an Ambulatory Surgery Center with accompanying outpatient clinic and rehabilitation services
- **Cincinnati** - moved to Dayton Children's Hospital in Dayton, OH
- **Salt Lake City** - transitioned to an outpatient clinic with accompanying rehabilitation services

- **Houston** - hospital closed and merged services with Galveston hospital
- **Twin Cities** - transitioned to an outpatient clinic with accompanying rehabilitation services
- **Tampa** - transitioned with the University of Florida and the University of Miami to become a foundation model of care delivery

Transitions are currently underway with hospitals in Shreveport and Springfield. There will most likely be additional hospitals transitioning into a different model of care in the coming months or years as healthcare transitions into more outpatient therapies. Shriners Children's Board remains committed to keeping our healthcare system on the cutting edge of change to ensure that we are best able to meet the needs of any and all children who could benefit from our care. It is an exciting time for us all as we continue to build awareness and support this amazing philanthropy!

## TEMPLE LEADERSHIP

Shrine Leadership positions have, for the newcomer, odd sounding titles. In addition, some positions are elected and some are appointed.

Appointments are made by the sitting Potentate. These positions make up the Board of Directors which manages the business of the Temple. This group is also referred to as the "Divan" and their Ladies are the "Divan Ladies."

### ELECTED

**Potentate** - This is, essentially, the President of the Shrine Temple. It is an elected position. The Nobles vote, annually, for their choice of Potentate.

**Chief Rabban** - 1st Vice President. As with the Potentate, this is also an elected position. It is expected that the Chief Rabban will, the following year, be elected to the position of Potentate.

**Assistant Rabban** - 2nd Vice President. This is also an elected position. It is expected that the Assistant Rabban will, the following year, be elected to the position of Chief Rabban.

**High Priest and Prophet** - 3rd Vice President. Another elected position. It is expected that the High Priest and Prophet will, the following year, be elected to the position of Assistant Rabban.

**Oriental Guide** - 4th Vice President – Also an elected position. This is the first position that enters the elected line of progression to Potentate. It is expected that the Oriental Guide will, the following year, be elected to the position of High Priest and Prophet.

**Treasurer:** Handles the financial matters of the temples, as is the norm for this position in most organizations. The incumbent does not progress through the line.

**Recorder:** Serves as secretary and many other related duties. This position also edits and publishes the Sudan magazine, The Red Fez. The incumbent does not progress through the line.

**APPOINTED** The sitting Potentate appoints these positions.

## SUDAN UNITS AND CLUBS

The Nobility is highly encouraged to join at least one Unit or Club. Units and Clubs are essential to Sudan Temple, providing members with a meeting place and defined social activities. There is a large variety in the Units and Clubs of Sudan, each dedicated to the Fraternity and under the jurisdiction of Sudan's Potentate. These organizations are composed of men who share a passion, enthusiasm or hobby. Many have Ladies' organizations which have meetings or offer activities for Ladies when they meet. With such a wide array of Units and Clubs offered in Sudan, a list has been composed providing a brief description of their mission and when they meet.

Units and Clubs have their own bylaws and, therefore, their own officers. Each Unit or Club defines the officers and terms of office. Many Units have international affiliations and, therefore, have their own conventions. Some occur during Imperial Session.

Imperial bylaws restrict Ladies from being in a Shrine parade. In Civic parades, Nobles, their Ladies, and children may participate **with the approval** of the Potentate, so long as their Ladies and children participate only as passengers in non-performing, non-competing vehicles with no less than 4 wheels. **HOWEVER**, Ladies are encouraged to attend parades, whenever possible. It's fun and shows your support of the Nobles and the Shrine.

The top five officers typically progress towards the Potentate position.

**Dress** - if the noble forgets to introduce his lady, it is said he must purchase a dress for her!

**Fez** - the red head gear worn by the Shriners

**High Priest and Prophet** - the third vice-president of the Temple Divan

**Hospitals** - the Shrine has 22 hospitals and/or other types of facilities to help children with orthopedic, spinal column, cleft lip and palate, and burn needs. The health system is now known as Shriners Children's

**Illustrious Sir** - title of the present and past Potentates

**Imperial** - the governing body of Shriners International

**Imperial Sir** - title given to an officer of the Imperial Divan

**Lady** - a spouse or female friend of a Shriner

**Masons** - every Shriner must be a member of this Fraternity, except in Arkansas

**Noble** - the title each Shriner is addressed by

**Oriental Guide** - the newest elected Divan member and fourth vice-president of the Temple

**Potentate** - the President or CEO of the Shrine Temple, elected for a one -year term

**Recorder** - responsible for the records of the Temple

**Shriners** - the authorized term for referring to the local nobles

**Shriners Hospitals for Children** - a Colorado Corporation

**Shriners International** - an Iowa Corporation

**SASA-South Atlantic Shrine Association**- representing 20 Shrine Temples and 7 states. They meet annually to celebrate, entertain and have unit and club competitions for fun.

**Stated Meeting** - the regular business meeting of the Temple
