### NOTICE

**The Annual Session of Sudan Shriners  
will be held at Grover C. Fields Middle School  
New Bern, NC  
January 24, 2026 – 8:00am**

For the election of Potentate, Divan Officers, Shriners International Representatives, SASA Representatives and New Candidates: the 2026 Budget Approval, and the transaction of such other business as may properly come before the temple.

#### Imperial Bylaws Article 325.11: Election Regulations

- (a) **Electioneering.** A candidate for an elected office in a Shrine temple may print, publish and circulate during the year he is seeking the elected office, a resume' consisting of his educational background, his vocational history, and his Masonic and Shrine record. Except as provided in the prior sentence, the printing, publication, circulating or distribution of resolutions, letters, telegrams, tickets, email or other devices, by a unit, club, noble, or group of nobles, suggesting, recommending, opposing, or containing the names of proposed candidates for office in the temple is prohibited.
- (b) **Expenditures Prohibited.** The expenditure of money for gifts, favors, or entertainment on behalf of a candidate for elected office is prohibited.
- (c) **Violation.** For any violation of (a) or (b), the Imperial Potentate may suspend any offending noble, and he may declare the election of the officers void and order a new election.
- (d) **Notice.** At least one week prior to the annual meeting or any election, the temple Recorder shall mail to each member a notice thereof containing this section.

## Colton Barbour's Story



On Saturday night at our 2025 Fall Ceremonial in Lumberton, NC, we were honored to meet and listen to a miraculous story about one of our long-term patients, Colton Barbour, who shortly after being born was treated over several years at our Shriners Children's. This article is a summary of his experiences as presented to our guests and the nobility by his parents and Colton himself. The photo above shows the Barbour family with our Sudan Potentate, Illustrious Sir E.T. "Tom" Ferrell III and Lady Milly.

"On July 12, 2007, at Duke Hospital, Colton Barbour entered the world weighing only three pounds eight ounces. Soon after, doctors diagnosed him with hemi vertebrae, a rare condition where part of a vertebra and rib fail to form. His parents were told that his spine would curve rapidly every few months—and that corrective action could not be taken until after age two. The prognosis offered little hope.

As predicted, Colton's spine continued to curve, compressing his lungs and leading to repeated bouts of pneumonia. His parents sought second opinions, but the outlook remained grim. Yet, through a chance encounter, Colton's father was introduced to the Shriners Hospital. As Colton's father Roy said, "it was not a coincidence it was a God thing." This connection brought Colton to Dr. Patrick Cayhill, who offered a groundbreaking surgical approach: fusing only five vertebrae rather than the entire spine, potentially sparing Colton from multiple surgeries.

The surgery was successful, but recovery was grueling. Colton's father recalls watching his son, trembling in pain, take each step with a walker while whispering to himself: "Never stop, never give up." That mantra became Colton's guiding light. With determination and therapy, he relearned walking and reclaimed his independence.

Once healed, Colton longed to be "just a normal kid." After convincing his parents and receiving his doctor's approval, he embraced sports—soccer, basketball, ultimate frisbee—and later discovered hunting and knee boarding. He experienced the joys of teenage life, graduated high school, and moved away to pursue higher education.

To Colton, success is not measured by the absence of scars or surgeries, but by the freedom to live without being defined by them. As he put it: ***"A successful surgery is when you don't think about it, you don't let what once held you back stop you, and you have a chance to be normal."***

Colton's story is more than medical triumph—it is a lesson in perseverance. His words echo as a challenge to us all: "Think about what you can do, set your mind to it, and never stop, never give up."

## Shriners Children's stresses the importance of burn prevention

For decades, Shriners Children's has been working to help reduce the number of preventable pediatric burn injuries by increasing awareness of the causes of burn injuries and offering prevention tips.

Burn Awareness Week, observed annually during the first full week of February, is the kickoff of our yearlong educational campaign. Free materials available via our website, including tip sheets and fact cards, are designed to be a resource for firefighters, teachers, parents and others concerned with the safety and well-being of children.

### Be Burn Aware

Burn Awareness Week is February 1-7, 2026. Building on the theme **Be Burn Aware**, our efforts focus on preventing burn injuries in the home, because that's where the majority of preventable burn injuries occur. Homes are the sites of thousands of burn injuries to children every year, including scalds, fire-related injuries, electrical burns and flammable liquid burns. With some simple precautions, many of these injuries may be prevented.

We have found that educational efforts have an impact: In the U.S., the occurrence of major pediatric burn injuries has decreased since campaigns like this one have been in place.

### FAST FACTS ABOUT BURN INJURIES FIRES

- Fires occur quickly. In less than 30 seconds a single flame can become a fire. In two minutes, it can become life-threatening; in five minutes a residence can be destroyed.
- Every year, hundreds of children under age 10 die in home fires.
- Fires and burns are a leading cause of injury-related fatalities among children under age 15.

### SCALDS

- Young children have thinner skin that burns more quickly than adults'. People of all ages can be burned in 30 seconds by a flowing liquid that is 130° F; at 140° F, it takes only five seconds; at 160° F, it only takes one second. For children under 5, these temperatures can cause a burn in half the time.
- Hundreds of children are taken to the emergency room every day with burn injuries, including scalds.
- Most scald injuries occur in residences. Scald burns are typically related to ordinary activities, including bathing, cooking and eating.

Historically, Tampa has been known as "Cigar City," from the industry that helped spawn the metropolis from a small town. But it is also sometimes known as The Big Guava – a reference to the fact that it was a search for wild guava trees that triggered events leading to the small village's initial growth.

In the 1880s, Spanish-born Vincente Martinez Ybor, a renowned Cuban cigar maker who had fled the island when accused of being a revolutionary, was searching for a new location for a cigar business. He happened upon an individual who was searching for wild guavas, who suggested Tampa. It was humid, had an excellent harbor and was developing shipping and rail lines.

Tampa was small then, but it was poised for great things. City fathers bought him land just north of town. That land became Ybor City and the cigar industry flourished. At its height, workers in the city's

numerous cigar factories rolled multiple millions of cigars annually.

Automation took its toll on Ybor City's livelihood in the 1930s, and the area languished for decades. It has been revived and renovated now, and just enough of the old cigar rolling town history remains to make it interesting. There are old factory buildings that have been repurposed; even some worker housing remains. The Ybor City Museum tells the story of cigar rolling and the mostly Latino community that flourished when the cigar industry was thriving and lucrative.

Ybor City is a short trolley ride from the convention center area and downtown.

For those who like to swim or lie back and feel the sun, let's not forget Tampa's beaches. St. Pete Beach was named the #1 beach in America by TripAdvisor in 2021; it's about 30 miles from downtown Tampa. Clearwater Beach is known for its fine sand and sunsets, and it's even closer, about 25 miles from downtown.

## FUNDRAISING ACTIVITIES

It is natural to associate the fez with Shriners Hospitals for Children. Because of this, meticulous attention must be given to all fundraising activities, including circuses, to make certain that such activities comply with the law of the land and that a contributor is not led to believe that his money will be used for the Hospitals when all or a portion thereof will be used otherwise. The integrity of our charity and of our fraternity must remain above reproach.

Your specific attention is called to the following fraternal and charitable bylaws:

## §335.3 USE OF NAME "SHRINERS HOSPITALS FOR

CHILDREN." The use of the name "Shriners Hospitals for Children" or reference to the Hospitals in connection with any fundraising activity by a temple or Noble without the written consent of the Imperial Potentate and the Chairman of the Board of Trustees of the Hospitals is prohibited.

## §503.11 COMMERCIAL USE OF NAME

The use of the name "Shriners Hospitals for Children" or reference to the Hospitals in connection with any commercial product or business enterprise is prohibited unless the written consent of the Board of Directors and Trustees has been first obtained.

Now, therefore, IT IS HEREBY ORDERED:

## 1. Fundraising for Fraternal Purposes:

- (a) No Noble (in his capacity as a Shriner), club, unit, organization of Nobles or affiliated or appendant corporations shall engage in any fundraising activity without the express written consent of the potentate of the temple having jurisdiction thereof.
- (b) There can be no representation, express or implied, that the proceeds will be for the benefit of Shriners Hospitals for Children.
- (c) The temple potentate shall carefully examine all phases of the advertising, promotion and solicitation to determine that it complies with §335.3 and §503.11 of the fraternal and charitable bylaws and that there is no representation, expressed or implied, that would lead a reasonably prudent person to believe that the proceeds will be for the benefit of Shriners Hospitals for Children. If the potentate is in doubt, he must receive the opinion of the Imperial Potentate who, after consultation with the Director of Temple Accounting, shall make the final determination.
- (d) The temple potentate must approve the terms and provisions of any contract for a fundraising activity after receiving the advice of the temple attorney, and additionally, as may be required by the temple bylaws.
- (e) A copy of the temple potentate's written consent shall be mailed to the Executive Vice President, Shriners International. Further, such written material pertaining to the fundraising activity, as requested by the Executive Vice President, Shriners International shall be promptly mailed to him.

## 2. Fundraising for Charitable Purposes:

- (a) No Noble (in his capacity as a Shriner), club, unit, organization of Nobles or affiliated or appendant corporations shall engage in any charitable fundraising activity other than for Shriners Hospitals for Children. Permission therefore must be first obtained in writing from the temple potentate. The temple potentate must then obtain written permission from the Chairmen of the Boards of Directors and Trustees. This request for written permission shall be sent to the Executive Vice President, Shriners International, P.O. Box 31356, Tampa, FL 33631-3356. No charitable fundraising activity shall be held in the jurisdiction of another temple without the written permission of the Potentate of that temple.
  - (1) A joint charitable fundraising activity with another 501(c)(3) charity may be authorized provided that a minimum of 50% of the net proceeds are for the benefit of Shriners Hospitals for Children, and the Chairmen of the Boards of Directors and Trustees determine, on a case by case basis, that it is in the best interest of Shriners Hospitals for Children and they grant their written permission for the activity.
  - (2) A charitable fundraising activity conducted by a temple located outside of the U.S.A may be authorized for other charities, provided that the chairmen of the board of directors and trustees determine, on a case by case basis, that it is in the best interest of Shriners Hospitals for Children and they grant their written permission for the activity.

- (b) 100% of net proceeds (as defined in the Charitable Fundraising-Approval And Reporting provisions of the current General Order) from charitable fundraising must be given to Shriners Hospitals for Children except for such portion thereof as may be permitted to be retained for the temple Shrine Hospital Patient Transportation Fund, pursuant to the Special Purpose Funds provisions of the current General Order. Provided, however, if the chairmen of the boards of directors and trustees determine for good cause shown, that the law of the land requires that a portion of the net proceeds must be distributed locally, then they may, if they determine it to be in the best interest of Shriners Hospitals for Children, grant their written permission for such distribution.
  - (c) The temple shall report the result of each charitable fundraising activity within sixty days of the activity, pursuant to the Charitable Fundraising-Approval And Reporting provision of the current General Order.
  - (d) This section shall not apply to activities exempt under §335.4(b) of the bylaws of Shriners International.
  - (e) Each independent corporation or entity that receives the permission of the chairmen of the boards of directors and trustees to raise moneys for Shriners Hospitals for Children, and which does not have its financial statements reviewed pursuant to §334.6 & §337.8 of the bylaws of Shriners International, shall have its financial statements audited by a certified, chartered or licensed public accountant and shall submit such audit report to Shriners International within 120 days of the activity.
3. Statement of Purpose and Disclosure:
- (a) Every fundraising activity must contain factual information on its solicitation material, tickets, programs and documents, including all electronically transmitted materials, regarding the use of the proceeds.  
Examples:  
*"Proceeds are for the benefit of ( \_\_\_\_\_ Shriners ) ( \_\_\_\_\_ Shrine Club ) activities."*  
*"Proceeds are for the benefit of Shriners Hospitals for Children."*
  - (b) Every fundraising activity which is not entirely for the benefit of Shriners Hospitals for Children shall prominently state on the solicitation material, tickets, programs, documents and electronically transmitted material that "payments are not deductible as charitable contributions."
  - (c) There must be compliance with the Revenue Act of 1987 provision of any existing general order by U.S. temples.
4. Compliance with Applicable Laws:  
It is the responsibility of the temple potentate, after receiving the advice of the temple attorney, to determine that there is compliance with all applicable laws in its jurisdiction for the temple's fundraising activities.
5. Financial Records:
- (a) The temple shall maintain detailed financial records pertaining to all fundraising activities involving Nobles, clubs, units, organizations of Nobles and affiliated and appendant corporations. Details of all revenues and expenditures shall be maintained in such financial records.
  - (b) The temple must retain such detailed financial records for a period of seven (7) years.
  - (c) There must be compliance with *Financial Reporting on Charitable Funds and Activities* provision of the current general order.
6. Notification to Nobility:  
A copy of the *Fundraising Activities* provisions of the current general order shall be printed in the temple publication at least once every calendar year. If there is no temple publication, then a copy shall be mailed to each Noble in the temple not later than the last day in March of each calendar year.
7. Discipline:  
Any officer, Noble or temple which violates a provision of *Fundraising Activities* is subject to discipline pursuant to the bylaws of Shriners International.
